

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.thedistinctionagency.com, and The Distinction Agency and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Distinction Agency include www.thedistinctionagency.com and The D.A.. The The D.A. website is a coaching & consulting site. By using the The D.A. website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, The D.A. may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase The D.A.'s products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

The D.A. may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through The D.A.'s public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Sharing Information with Third Parties

The D.A. does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Right to Deletion

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
